Motion to Affirm the Six Key Priorities for the Building Enhancement Project

Carl English Young gave a summary of the Building Enhancement Project and then presented the following motion:

The Unitarian Universalist Fellowship of Corvallis affirms the continuance of the Building Enhancement Project. The Project will work toward the achievement of these six key priorities.

- Conducting Structural Engineering Study and Geotechnical Analysis
- Meeting Current Code for Fire Safety and Sidewalk Requirements
- Improving Heating and Ventilation for the Current Sanctuary and Seeking Every Opportunity for Energy Efficiency
- Installing New Flooring in the Sanctuary
- Building a New Social Hall, Kitchen and Restrooms
- Creating New Outflow from Our Parking Lot to Elmwood street with Some Additional Parking Spaces

Diana Vezmer-Bailey so moved, and Leslie Chartier seconded it. A discussion followed.

Jim Good proposed a friendly amendment that we accept all these six points and allow time for more input on design. Diana accepted it as the maker of the original motion.

The final amended motion passed with only three votes against.

In favor of the original motion with the friendly amendment

Nominating Committee Presented the Slate of Nominees

Carl presented the FY 2018 operating budget. Eileen Maxfield made the motion to accept it, and Carolyn Madsen seconded it.
